Mary Lee's House provides a safe and nurturing environment that ensures children that have been abused are not traumatized again by the systems designed to protect them.



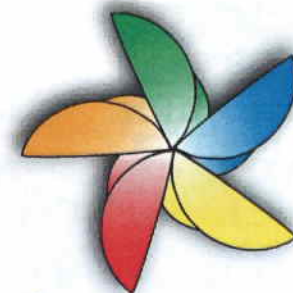
